Massachusetts Institute of Technology professor, linguist, U.S. political theorist, and activist [Noam Chomsky](#) will be speaking at Central Presbyterian Church (1660 Sherman St.) in Denver on May 7, 2013 at 7 p.m. The talk is titled "An Evening with Noam Chomsky" and is a benefit to raise money for the Boulder-based radio station [KGNU](#), which is celebrating its 35th birthday.

- Privatization leads to the destruction of the commons - the Charter of the Forests has been dismantled bit by bit in England and in the US. Only the "primitive people" are trying to keep this alive.

### **2013, May 2 Francine Wheeler and Peter Yarrow on Music's Power in Social Movements**

Francine Wheeler, whose youngest son was killed in the December 14th attack at Sandy Hook Elementary School in Connecticut, joins folk singer Peter Yarrow of Peter, Paul and Mary fame to discuss the power of music to create change, and their mission to protect children and adults from gun violence in communities across America. We also see excerpts from a February 2013 concert of harmony, resilience and solidarity that Yarrow helped conceive, during which Yarrow and Wheeler sang. The concert will soon be broadcast on many public television stations.

"An act of positive movement forward is singing together. This is not a benign thing," Yarrow tells Bill. "Woody Guthrie had his guitar and said, 'this machine kills fascists'... This is so powerful a tool that when you galvanize people's hearts together, and they create that movement by singing together, you're not saying, 'Oh, look how prettily I can sing.'"

Wheeler says they're focusing on core values that most people have in common, not issues that drive them apart. "There are a lot of responsible gun owners out there, some of whom are NRA members. And they want safety for their children and for their grandchildren," she tells Bill. "So, what we're talking about is, hey, why don't we find a way to not debate and fight about what you believe guns are and what I believe guns are. Let's come together and figure out a way to make them safer."

# 2013, May 18 U.S. Military ‘Power Grab’ Goes Into Effect

## **Pentagon Unilaterally Grants Itself Authority Over ‘Civil Disturbances’**

The manhunt for the Boston Marathon bombing suspects offered the nation a window into the stunning military-style capabilities of our local law enforcement agencies. For the past 30 years, police departments throughout the United States have benefitted from the government’s largesse in the form of military weaponry and training, [incentives offered in the ongoing “War on Drugs.”](#) For the average citizen watching events such as the intense pursuit of the Tsarnaev brothers on television, it would be difficult to discern between fully outfitted police SWAT teams and the military.

The lines blurred even further Monday as a new dynamic was introduced to the militarization of domestic law enforcement. By making a few subtle changes to a regulation in the U.S. Code titled “[Defense Support of Civilian Law Enforcement Agencies](#)” the military has quietly granted itself the ability to police the streets without obtaining prior local or state consent, upending a precedent that has been in place for more than two centuries.

The most objectionable aspect of the regulatory change is the inclusion of vague language that permits military intervention in the event of “civil disturbances.” According to the rule:

Federal military commanders have the authority, in extraordinary emergency circumstances where prior authorization by the President is impossible and duly constituted local authorities are unable to control the situation, to engage temporarily in activities that are necessary to quell large-scale, unexpected civil disturbances.

Bruce Afran, a civil liberties attorney and constitutional law professor at Rutgers University, calls the rule, “a wanton power grab by the military,” and says, “It’s quite shocking actually because it violates the long-standing presumption that the military is under civilian control.”

A defense official who declined to be named takes a different view of the rule, claiming, “The authorization has been around over 100 years; it’s not a new authority. It’s been there but it hasn’t been exercised. This is a carryover of domestic policy.” Moreover, he insists the Pentagon doesn’t “want to get involved in civilian law enforcement. It’s one of those red lines that the military hasn’t signed up for.” Nevertheless, he says, “every person in the military swears an oath of allegiance to the Constitution of the United States to defend that Constitution against all enemies foreign and domestic.”

One of the more disturbing aspects of the new procedures that govern military command on the ground in the event of a civil disturbance relates to authority. Not only does it fail to define what circumstances would be so severe that the president’s authorization is “impossible,” it grants full presidential authority to “Federal military commanders.” According to the defense official, a commander is defined as follows: “Somebody who’s in the position of command, has the title commander. And most of the time they are centrally selected by a board, they’ve gone through additional schooling to exercise command authority.”

As it is written, this “commander” has the same power to authorize military force as the president in the event the president is somehow unable to access a telephone. (The rule doesn’t address the statutory chain of authority that already exists in the event a sitting president is unavailable.) In doing so, this

commander must exercise judgement in determining what constitutes, “wanton destruction of property,” “adequate protection for Federal property,” “domestic violence,” or “conspiracy that hinders the execution of State or Federal law,” as these are the circumstances that might be considered an “emergency.”

“These phrases don’t have any legal meaning,” says Afran. “It’s no different than the emergency powers clause in the Weimar constitution [of the German Reich]. It’s a grant of emergency power to the military to rule over parts of the country at their own discretion.”

Afran also expresses apprehension over the government’s authority “to engage temporarily in activities necessary to quell large-scale disturbances.”

“Governments never like to give up power when they get it,” says Afran. “They still think after twelve years they can get intelligence out of people in Guantanamo. Temporary is in the eye of the beholder. That’s why in statutes we have definitions. All of these statutes have one thing in common and that is that they have no definitions. How long is temporary? There’s none here. The definitions are absurdly broad.”

The U.S. military is prohibited from intervening in domestic affairs except where provided under Article IV of the Constitution in cases of domestic violence that threaten the government of a state or the application of federal law. This provision was further clarified both by the Insurrection Act of 1807 and a post-Reconstruction law known as the Posse Comitatus Act of 1878 (PCA). The Insurrection Act specifies the circumstances under which the president may convene the armed forces to suppress an insurrection against any state or the federal government. Furthermore, where an individual state is concerned, consent of the governor must be obtained prior to the deployment of troops. The PCA – passed in response to federal troops that enforced local laws and oversaw elections during Reconstruction – made unauthorized employment of federal troops a punishable offense, thereby giving teeth to the Insurrection Act.

Together, these laws limit executive authority over domestic military action. Yet Monday’s official regulatory changes issued unilaterally by the Department of Defense is a game-changer.

The stated purpose of the updated rule is “support in Accordance With the Posse Comitatus Act,” but in reality it undermines the Insurrection Act and PCA in significant and alarming ways. The most substantial change is the notion of “civil disturbance” as one of the few “domestic emergencies” that would allow for the deployment of military assets on American soil.

To wit, the relatively few instances that federal troops have been deployed for domestic support have produced a wide range of results. Situations have included responding to natural disasters and protecting demonstrators during the Civil Rights era to, disastrously, the Kent State student massacre and the 1973 occupation of Wounded Knee.

Michael German, senior policy counsel to the American Civil Liberties Union (ACLU), noted in a 2009 Daily Kos article that, “there is no doubt that the military is very good at many things. But recent history shows that restraint in their new-found domestic role is not one of them.”

At the time German was referring to the military’s expanded surveillance techniques and hostile interventions related to border control and the War on Drugs. And in fact, many have argued that these actions have already upended the PCA in a significant way. Even before this most recent rule change, the ACLU was vocal in its opposition to the Department of Defense (DoD) request to expand domestic military authority “in the event of chemical, biological, radiological, nuclear, or high yield explosive (CBRNE) incidents.” The ACLU’s position is that civilian agencies are more than equipped to handle

such emergencies since 9/11. (ACLU spokespersons in Washington D.C. declined, however, to be interviewed for this story.)

But while outcomes of military interventions have varied, the protocol by which the president works cooperatively with state governments has remained the same. The president is only allowed to deploy troops to a state upon request of its governor. Even then, the military – specifically the National Guard – is there to provide support for local law enforcement and is prohibited from engaging in any activities that are outside of this scope, such as the power to arrest.

Eric Freedman, a constitutional law professor from Hofstra University, also calls the ruling “an unauthorized power grab.” According to Freedman, “The Department of Defense does not have the authority to grant itself by regulation any more authority than Congress has granted it by statute.” Yet that’s precisely what it did. This wasn’t, however, the Pentagon’s first attempt to expand its authority domestically in the last decade.

### **Déjà vu**

During the Bush Administration, Congress passed the 2007 Defense Authorization Bill that included language similar in scope to the current regulatory change. It specifically amended the Insurrection Act to expand the president’s ability to deploy troops domestically under certain conditions including health epidemics, natural disasters and terrorist activities, though it stopped short of including civil disturbances. But the following year this language was repealed under the National Defense Authorization Act of 2008 via a bill authored by Vermont Senator Patrick Leahy (D-VT) who cited the “useful friction” between the Insurrection and Posse Comitatus Acts in limiting executive authority.

According to the DoD, the repeal of this language had more to do with procedure and that it was never supposed to amend the Insurrection Act. “When it was actually passed,” says the defense official, “Congress elected to amend the Insurrection Act and put things in the Insurrection Act that were not insurrection, like the support for disasters and emergencies and endemic influenza. Our intent,” he says, “was to give the president and the secretary access to the reserve components. It includes the National Guard and, rightfully so, the governors were pretty upset because they were not consulted.”

Senator Leahy’s office did not have a statement as of press time, but a spokesperson said the senator had made an inquiry with the DoD in response to our questions. The defense official confirmed that he was indeed being called in to discuss the senator’s concerns in a meeting scheduled for today. But he downplayed any concern, saying, “Congress at any time can say ‘we don’t like your interpretation of that law and how you’ve interpreted it in making policy’ – and so they can call us to the Hill and ask us to justify why we’re doing something.”

Last year, Bruce Afran and another civil liberties attorney Carl Mayer [filed a lawsuit against the Obama Administration](#) on behalf of a group of journalists and activists lead by former *New York Times* journalist Chris Hedges. They filed suit over the inclusion of a bill in the [NDAA 2012](#) that, according to the plaintiffs, expanded executive authority over domestic affairs by unilaterally granting the executive branch to indefinitely detain U.S. citizens without due process. The case has garnered international attention and invited vigorous defense from the Obama Administration. Even Afran goes so far as to say this current rule change is, “another NDAA. It’s even worse, to be honest.”

For Hedges and the other plaintiffs, including Pentagon Papers whistleblower [Daniel Ellsberg](#), the government’s ever-expanding authority over civilian affairs has a “chilling effect” on First Amendment activities such as free speech and the right to assemble. First District Court Judge Katherine Forrest agreed with the plaintiffs and handed Hedges et al a resounding victory prompting the Department of

Justice to immediately file an injunction and an appeal. The appellate court is expected to rule on the matter within the next few months.

Another of the plaintiffs in the Hedges suit is [Alexa O'Brien](#), a journalist and organizer who joined the lawsuit after she discovered a Wikileaks cable showing government officials attempting to link her efforts to terrorist activities. For activists such as O'Brien, the new DoD regulatory change is frightening because it creates, "an environment of fear when people cannot associate with one another." Like Afran and Freedman, she too calls the move, "another grab for power under the rubric of the war on terror, to the detriment of citizens."

"This is a complete erosion of the rule of law," says O'Brien. Knowing these sweeping powers were granted under a rule change and not by Congress is even more harrowing to activists. "That anything can be made legal," says O'Brien, "is fundamentally antithetical to good governance."

As far as what might qualify as a civil disturbance, Afran notes, "In the Sixties all of the Vietnam protests would meet this description. We saw Kent State. This would legalize Kent State."

But the focus on the DoD regulatory change obscures the creeping militarization that has already occurred in police departments across the nation. Even prior to the [NDAA lawsuit](#), journalist [Chris Hedges](#) was critical of domestic law enforcement agencies saying, "The widening use of militarized police units effectively nullifies the Posse Comitatus Act of 1878."

This de facto nullification isn't lost on the DoD.

The DoD official even referred to the Boston bombing suspects manhunt saying, "Like most major police departments, if you didn't know they were a police department you would think they were the military." According to this official there has purposely been a "large transfer of technology so that the military doesn't have to get involved." Moreover, he says the military has learned from past events, such as the siege at Waco, where ATF officials mishandled military equipment. "We have transferred the technology so we don't have to loan it," he states.

But if the transfer of military training and technology has been so thorough, it boggles the imagination as to what kind of disturbance would be so overwhelming that it would require the suspension of centuries-old law and precedent to grant military complete authority on the ground. The DoD official admits not being able to "envision that happening," adding, "but I'm not a Hollywood screenwriter."

Afran, for one, isn't buying the logic. For him, the distinction is simple.

"Remember, the police operate under civilian control," he says. "They are used to thinking in a civilian way so the comparison that they may have some assault weapons doesn't change this in any way. And they can be removed from power. You can't remove the military from power."

Despite protestations from figures such as Afran and O'Brien and past admonitions from groups like the ACLU, for the first time in our history the military has granted itself authority to quell a civil disturbance. Changing this rule now requires congressional or judicial intervention.

"This is where journalism comes in," says Freedman. "Calling attention to an unauthorized power grab in the hope that it embarrasses the administration."

Afran is considering amending his NDAA complaint currently in front of the court to include this regulatory change.

As we witnessed during the Boston bombing manhunt, it's already difficult to discern between military and police. In the future it might be impossible, because there may be no difference.

**Children Born With Advanced DNA**

This is an incredible story of children being born with advanced DNA. ### **Children of the New Dream**

Interview with Drunvalo Melchizedek By Diane Cooper

**Diane:** So Drunvalo...who are these "Children of the New Dream" that you are so excited about?

**Drunvalo:** Well there are 3 different kinds of children emerging in the world today that I have been able to identify. The first are called the "Super Psychic Children of China." The second are called the "Indigo Children" and the third are called the "Children of AIDS."

....It is the third group that I am most interested in—the "Children of AIDS." About 10 or 11 years ago in the US, there was a baby born with AIDS. They tested him at birth and at 6 months and he tested positive for AIDS. They tested him a year later and he still tested positive. Then they didn't test him again until he was 6, and what was amazing is that this test showed that he was completely AIDS free! In fact, there was no trace that he ever had AIDS or HIV whatsoever! He was taken to UCLA to see what was going on and those tests showed that he didn't have normal human DNA.

In the human DNA we have 4 nucleic acids that combine in sets of 3 producing 64 different patterns that are called codons. Human DNA all over the world always has 20 of these codons turned on and the rest of them are turned off, except for 3 which are the stop and start codes, much like a computer. Science always assumed that the ones that were turned off were old programs from our past. I've always seen them like application programs in a computer. Anyway... this boy had 24 codons turned on — 4 more than any other

human being. Then they tested this kid to see how strong his immune system was. They took a very lethal dose of AIDS in a petri dish and mixed it with some of his cells and his cells remained completely unaffected. They kept raising the lethality of the composition and finally went up to 3,000 times more than what was necessary to infect a human being and his cells stayed completely disease free.

Then they started testing his blood with other things like cancer and discovered that this kid was immune to everything! Then they found another kid with these codons turned on—then another one then another one—then 10,000, then 100,000, then a million of them and at this point, UCLA, by watching world-wide DNA testing, estimates that 1% of the world has this new DNA. That breaks down to approximately 60 million people who are not human by the old criteria.

**Diane:** Is this new codon activation found only in newborn children?

**Drunvalo:** Well, it's mostly children, but now they are finding adults with it too—just like the hundredth monkey theory. Now all kinds of people are being affected by it and it's spreading fast. Remember, it started just 5 years ago with almost no one and now it's spreading—just like a disease. It's like an outbreak and this is only the beginning.

The other part of this concerns the new book entitled "Cracking the Bible Code"—which has to do with running the Hebrew Books of the Bible through a specialized computer program. If you go to page 164 of this book, it shows where these researchers put the word AIDS into the program to see what would happen. When they did, the program translation provided words like "HIV," "in the blood," "the immune system," "death" — all the things you would think you'd see around the word AIDS, but down in the corner was this sentence that they didn't understand and it said — "the end of disease," and that is what I believe is happening here.

"Science has stated that there are so many people showing up with this new alien DNA that they now believe that a new human race is being born on the earth today and apparently they can't get sick." Now what is really incredible — they believe that it is a very specific emotional, mental body response — a waveform coming off the body that is causing the DNA to mutate in a certain way. I've sat with Gregg Braden who was one of the first persons to write about this and what we believe is that there are 3 parts to this phenomenon.

"The first part is the mind that sees Unity." It sees the Flower of Life. It sees everything interconnected in all ways. It doesn't see anything as separate. And the "second part is being centered in the heart—to be Loving." And the "third thing is to step out of polarity—to no longer judge the world." As long as we are judging the world as good or bad, then we are inside polarity and remain in the fallen state. I believe these people (with the new DNA) have somehow stepped out of judging and are in a state where they see everything as one and feeling Love. Whatever they are doing within themselves is producing a waveform that when seen on computer screens looks almost identical to the DNA molecule. So the researchers think that by the very expression of their life that these people are mapping with the DNA — resonating it — and are changing these 4 codons and in so doing become immune to the disease. What they don't know and this is where a lot of research gets to happen is so maybe they are immune, but is there anything else? They might be immortal, who knows. Maybe there are other characteristics that we haven't even dreamed of. I often wonder if they are all linked together? Is there some form of telepathic connection that goes on?

**Diane:** Have you met any of these people? Are they accessible?

**Drunvalo:** Well, I've known about this for over two years and I have personally followed this path and I think I've moved into what they are doing. I have gone into the merkabah and asked my subconscious mind to change my codons in the same way and ever since I began to do this over two years ago, I haven't been able to get sick. I don't know if I've been able to change them or not. I guess the only way I'd know is with a DNA test. However, I've been exposed to all kinds of things and when someone gets sick I purposely get

close to them and try to get it. I've been trying to get sick — and I can't feel something come on — it will last maybe an hour and then it's gone. What is interesting is that hardly any of this new DNA is found in the Super Psychic Children of China — almost zero. It is, however, being found in Russia and the U.S. There seems to be pockets of it and if what we are thinking is right — it has to do with a very specific response which is where most people in the New Age are headed for.

**Diane:** Do you think these people are creating the DNA changes unconsciously?

**Drunvalo:** I think someone has made the path — one child did it somewhere. Then he put it into the grids and it is now in the subconscious of the earth and is accessible to anyone. Once that happened I think somehow or another other people have connected to this on a subconscious level in deep meditation and prayer and made the change. A new race is being born and it is one of the most remarkable phenomenon that has happened on the planet! It's incredible that no one seems to know about this until now!

**Diane:** Well, you are the only one I've ever heard speak about this.

**Drunvalo:** Well, I've been tracking this for about 2 years and I've waited to say anything because I wanted to make sure it was real. In the book called "The Indigo Children" there has been extensive research on these children. There are websites you can go to if you're a parent where they begin to interview you about exactly what's going on with your child. Like I said earlier, these kids know exactly what you're feeling and what you're thinking.

You can't hide anything from them. It's really amazing! I see it as a phenomenon like the ETs except they aren't coming here in spaceship form — they are coming here in spirit form making it personal by coming into the earth's evolutionary cycle and joining with us. I've often thought that when spirits come in on the right side of the planet — Japan, China, and Tibet for instance, the incarnating being takes on the psychic characteristics (of those people), and if they come in on the western side — the logical side (i.e., physical characteristics) — then the DNA comes in changed. But that's just speculation on my part. I'm just looking at this and trying to understand what is occurring. At the workshops I'm going to do, I'm going to bring everything I've learned together and teach people to actually access this and make the change. I think I know — or I'm very close.

**Diane:** And that has to do with putting yourself in a certain state of consciousness?

**Drunvalo:** Yes, a very specific state of consciousness produces a change in your DNA — and I think it's just the beginning of much more than that. The fact that it could be the end of disease is just a tiny bit of the total picture.

**Diane:** How would this particular kind of work and discovery affect the DNA activation work that seems to be popping up all over?

**Drunvalo:** Well, if you know your light body and you know how psychic energy works and if you understand the connection of the subconscious to all life on this planet, then you can go in and ask your subconscious. "Your subconscious knows exactly which codons those kids have changed and if you ask for those things to happen through your light body and in the presence of God," it should occur. "[/b]It also requires dropping polarity — no longer thinking in terms of good or bad but seeing the wholeness and completion and perfection of life."

It is a very definite mind, emotional and body response. The body response is the one where your body simply does not acknowledge good or bad but sees that there is a higher purpose behind it all. **Diane:** So, if that's the case, then what significance does that have on our lives today?

**Drunvalo:** I believe that all of us have the choice to follow this particular pattern that the children have set up or not. It is said that "the children will lead the way." If we wish to and we trust these children, as I do, one of the side effects is the immunity to disease.

**Diane:** There are a lot of us who are choosing immortality. However, some people would say that to be immune to disease is also to upset the life/death cycle which has supposedly helped to keep the planet in balance. How would you answer that?

**Drunvalo:** Well, I just don't judge it. This is happening and if it is going to upset the cycle and it probably will in some way – everything that is occurring in life has a reason and purpose for it. Perhaps these people who don't get sick anymore perhaps they won't even die anymore and maybe their consciousness is so aligned with the original purpose of earth that ultimately it would mean an earth that is whole and complete and not one that is polluted and deadly and overtaxed. We could easily live with 6 billion people or 20 billion... if... we live differently.

There is plenty of space, and it's just that we are using our resources in ways that are killing the planet. If we were to choose to live in different ways, that might change. Maybe through these people the answers might become apparent. For someone to move into a state where they are immune to disease is a very powerful indication that they are definitely in harmony with life somehow.

We can equate this process with the mutation of bacteria and viruses. We attack their systems with pollutants such as penicillin, for instance, and it kills them all except for a few. Those few get stronger. Now what's happening is that these bacteria are getting to the place where they are immune to the poisons we are giving them. And have we not done the same thing?

We are mutating to a point where we are not affected by pollution or viruses or by disease. And you know, there is another thing that happened last year — AIDS dropped something like 47% — the largest drop of a single disease in the history of the world. I believe that it had a lot to do with this very thing we are talking about.

**Diane:** That's exciting!

**Drunvalo:** Yes, it is. I just let the earth prompt me where to go. Of course, it is important to know our light bodies and how to use them, but the children are very carefully saying – come this way – and see where this leads.
