GUIDELINES FOR SUBMISSIONS:

- demo reels should be in 16:9 for best results when compiled with the other reels.
- Please be sure to take 5 seconds to include your name, and contact information at the beginning and end of the reel. If people like what they see, they need to know who to contact. Also, by "bookending" your demo with the contact info, it ensures that they do not confuse the end of someone else's reel with the beginning of yours, or visa versa.
- If you submit your demo reel on DVD-ROM, please be sure the video file is rendered in one of the two file formats: For PC's: AVI, DV Codec, 720x480. For Mac: MOV, NTSC DV/DVCPRO Codec, 720x480. In either case, your rendered file should be approximately 500MB. If it is not about 500MB, then you probably did not render it to these specifications.
