### VENDOR AGREEMENT

### 2016 FEAST OF THE BLESSED SACRAMENT

AGREEMENT made by and between COMMITTEE OF THE FEAST OF THE BLESSED SACRAMENT, of New Bedford, Massachusetts, sponsored by CLUB MADEIRENSE S.S. SACRAMENTO, INC., hereinafter referred to as the "COMMITTEE", and \_\_\_\_\_ of \_\_\_\_\_ herein, after referred to as the "VENDOR".

Whereas, the COMMITTEE agrees to celebrate the 102nd FEAST OF THE BLESSED SACRAMENT in the city of New Bedford, Massachusetts, on Thursday, Friday and Saturday proceeding the first Sunday in the month of August, being the following dates: August 4<sup>th</sup> through August 7<sup>th</sup>, 2015.

NOW, THEREFORE, it is hereby agreed that said VENDOR will install and maintain a booth measuring approximately \_\_\_\_\_ and designated booth # \_\_\_\_\_ on the premises located on Madeira Avenue and/or Hathaway Street, New Bedford, Massachusetts, for the sale of \_\_\_\_\_ and no other purpose. The VENDOR agrees not to dispense any other commodities or products without the express permission of the COMMITTEE in writing by the President. **In addition, the VENDOR agrees to not display / sell any products that contain Vulgar / Profane words or images deemed to be inappropriate by the COMMITTEE.** And, in the consideration of the foregoing Agreement and the privileges therein described and granted by the COMMITTEE, the said VENDOR will pay the COMMITTEE the sum of \_\_\_\_\_ DOLLARS in advance.

It is further agreed that the VENDOR shall hold harmless and indemnify the COMMITTEE and its sponsor, the CLUB MADEIRENSE S.S. SACRAMENTO, INC., of New Bedford, Massachusetts, from any loss or injury to any property or any person caused by any action or omission by the VENDOR, or any of its agents, in the public, or COMMITTEE member, from the time the VENDOR arrives on the premises to the time he departs. The COMMITTEE will not be responsible for any losses of any kind whatsoever due to the operation of said booth by said VENDOR.

It is further agreed that no monies will be refunded by said COMMITTEE to the said VENDOR in the event of rain.

In the event that said VENDOR cancels this Agreement, or any part thereof, or fails to perform the same, then in that event the sum agreed to herein shall be due to the COMMITTEE from said VENDOR as liquidated damages, and any monies paid to the COMMITTEE are to be applied against said sum due the COMMITTEE.

THE COMMITTEE MAKES NO REPRESENTATIONS OR GUARANTEES OF ANY KIND AS TO THE FINANCIAL SUCCESS OF SAID BOOTH TO BE OPERATED BY THE VENDOR.

If any provision of the Agreement is deemed to be illegal, or against public policy, the remainder of this Agreement shall not be affected thereby.

The making of payments at the times they respectively fall due shall be considered as the essence of this Agreement; and in case of failure so to do, or in case the VENDOR shall fail to make any other payment due to the COMMITTEE, the COMMITTEE shall have the right to cancel any contract and to declare due the entire amount unpaid.

It is hereby declared and agreed by the VENDOR that it has entered this Agreement, relying on its own knowledge, and not upon any representations made by the COMMITTEE or by any other person touching the situation, character or quality thereof.
