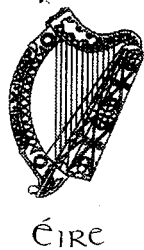

It transpired at the meeting, that the Irish Republican Brotherhood would hand over the Sovereignty of the Sovereign Republic of Eire and ~~Dáil Eireann~~ to the present provisional Government that was imposed by King George V of England in 1922 under the threat of "Immediate and Terrible War" as a British Apartheid system for the 26 and 6 Counties of Ireland as an Orange Free State for Ireland and a Provisional Government for the 26 and 6 Counties of Ireland.

All legal, Valid and Bona-fide Licences are turned on the 21<sup>st</sup> of January each and every year to the 20<sup>th</sup> of January every year.

The Dublin City Manager announced that they were redeveloping Parnell Square Dublin. I asked the City Manager office to purchase G.H.Q. "Vaughan's Hotel" 29 Parnell Square and Granby Row Dublin The Headquarters of The Irish Republican Brotherhood and O'Connell's Park Éireann where the State The Sovereigns Republic of Éire, Dáil Éireann, and The Dáil Éireann Courts (4 Courts) were founded and the Sovereigns Constitution was written. The 32 County election of 1918. and The War of Independence were conducted.

The Dublin City Manager's office told me that they were holding a 1916 I.R.B. conference at Wood Quay offices on the 26<sup>th</sup> of April 2013.

I asked that The Irish Republican Brotherhood would be invited to the Conference and I was told that all the speakers, had already been appointed

When I and the chairman arrived on the 26 of April 2013 we were refused admission to the conference. We were not abusive or threatening to Dublin City Council staff or conference organisers. In fact we gave them, Irish Republican Brotherhood Sovereign Seal Harp badges, which they greatly appreciated.

My letter of the 15-XII-2013, explains the importance of the founding of the Irish Republican Brotherhood on St Patrick's day in 1858 by James Stephens at 16 Lombard Street Dublin. Your contempt for the Irish Republican Brotherhood. Take down the Irish Republican Brotherhood's Tricolour Flag that you are desecrating, illegally and fraudulently using at the Mansion House Dublin
