LOCATION: The Salyards Center for the Arts, Conway, NH

REQUIREMENTS and NOTES:

- This is a **juried member** show. If you have a question as to whether or not you are a juried member, call the office. If you need a jurying application, please call the office or download a form from our website at www.mwvarts.org.
- **Show Exhibit Area:** Framed original paintings, photography, mixed media, original prints such as etchings, 3-dimensional art, and fine crafts are welcome.
- All work submitted must be the ORIGINAL work of the artist. Work based on published photographs or other artists' work as well as work produced in classes, workshops or under the direct supervision of an instructor should not be submitted.
- 2-dimensional pieces must be securely framed, **wired**, and ready to hang. For 3-dimensional work, staging is welcomed.
- All work must not have been exhibited at any MWVAA group member show during the last 3 years (2007-2009).
- **The Shop:** A separate area will be created for each exhibitor to sell prints, note cards, matted original watercolors, matted photographs, fine crafts, etc. Members must have at least one piece in the Show Exhibit Area to have pieces in The Shop. Limit of 10 pieces per exhibitor.
- All exhibitors will be required to sit this year's show.
- The MWVAA reserves the right not to display works deemed inappropriate by the Board.
- A People's Choice Award will be given.

JURY PROCESS: If you are a new member or have not exhibited work within the past three years in an MWVAA show or exhibit, you will need to participate in the jury process. The jury application may be submitted by mail, via email, or in person along with 3-5 examples of your work. The next in person jury session is at the MWVAA Office on Monday, September 21st. Please call for an appointment.

ENTRY FEE: **Show Exhibit Area:** \$10 per piece, maximum of 3 pieces. If you did not exhibit at the Kaleidoscope show, you are entitled to 1 free entry.
The Shop: No additional entry fee. Limit 10 pieces per exhibitor.

COMMISSION: 20% to the MWVAA (If any sales generated by this show are made following the show, the 20% commission is due to the MWVAA.)

DEADLINE TO APPLY: Show applications must be postmarked by September 25, 2009.
Jury applications must be received by e-mail or regular mail by September 16, 2009.

WORK DROP OFF: **Thursday, October 8, from 11:00 to 1:00.** (Please bring a 1-page biography in a plastic sleeve that can be placed in a 3-ring binder. Business cards may be displayed on the table.)

WORK PICK UP: **Sunday, October 11, from 4:00 to 5:00 p.m. ALL WORK MUST REMAIN ON DISPLAY UNTIL 4:00 ON SUNDAY WHEN THE SHOW CLOSES.**
