**R:** talked to **4 ravens today**; fed them popcorn –

- they had a 5 minute chat - were saying we're all in this together
- **Natasha** described it: we are watching a slow moving train crash, moving at quantum light speed and it's affecting everything

- describes her participation in a Vision quest for a group – her favourite ceremony because it is a community activity: the questors spend time with an elder to get ready for the quest
  - this one was unusual: part of midwifing a community in Mexico who are partnering with an elder in North Carolina. The elder had been going down to Mexico and for this piece, he had a fire up in NC, and they had a fire in Mexico. Referred to it as a kind of weaning.
    - Rainbird knew some of the questors & the teacher who'd been a student of Rocking Bear
    - she was one of the 3 ground people who held the fire for the 13 questors, age 13 – 65
  - first 2 days, went well then the weather changed and they could all feel it
  - learned about Grandmother Spider a creator – was 8' under the fire which is sacred and she was also under the fire in Mexico
  - tells how she got involved in this activity;
    - Rocking Bear who was Rainbird's teacher came to visit them as a yellow butterfly – at the end of November!!!
    - When she was asked about how to get involved in such things – ask the Universe!
  - More about the quest:
    - She and her companions kept the fire: had to set up an invisible fire – it was in a nice sized yard with a privacy fence which was originally for the dog
      - They turned it into a open air medicine room and put the fire in an area where no one could see it! So they had an invisible fire with hoses available – had a cornmeal boundary around it which acted like a force field, thanks to their special prayers.
  - Copal – one of the materials she uses for smudges; can get it on a stick like an incense stick – it's a resin that comes out of a tree: has a pine-y smell.
  - Describes how to use cornmeal to respect nature
    - the nature beings participate when we have ceremony outside
  - when she was on one of her quests, Rama appeared. She tells the story of this first quest
    - had described the making of prayer ties and their use
- Cmdr Randy:** has seen ravens in the tropics – making all kinds of noise: have never seen this before – and Rama has just fed ravens this week too!!
- a group of crows: a murder of crows
- the keeper of the fire: has to be precise – in ceremony, full of reverence;

**Cmdr Randy:** has learned that one has to build one's own fire

**Raven #16 Medicine card book** = magic. This is true in all cultures -

- those who fear raven may have been dabbling in the dark side. Raven magic is a powerful magic that give you courage to go into the Great Void. If Raven appears in the spread of the cards, this may involve you have
- raven's colour is black as the black hole [the Void] – does not mean evil.
- Raven is the guardian of ceremonial magic: raven will be present in any healing circle  
So Randy has ravens coming to help him with his healing work.
- The raven is the power of the unknown at work – can you accept the Great Mystery?

- The message? Goddess is afoot,

**MR:** being present with the indigenous protests

**T:** impressed with the international indigenous group of representatives showing up

**RB:** is Obama's double agency showing up? Doesn't make sense that he can't do anything

**T:** because of the controlling energy in that seat.

**R:** in a certain sense, the ravens gathering is the gathering of the wizards, good sorcerers gathering to bring assistance in the face of the scary stories out there. People don't understand very much about what is happening.

**MR:** have had red hawks in their area for the last 2 years – hadn't been there before  
now really present in her area

**T:** story of a red tailed hawk

- also about an owl in another valley in Hawaii
- there is a message, always, from the birds

**MR:** all of a sudden her dog wants to get her attention so much – has never done that before – started when she began the reading from the medicine cards

**RB:** Reads from her Rocking Bear Card:

- living life as a sacred human being: pay attention, pay attention, pay attention.



In an independent initiative of the **Original Nations of Indigenous Peoples** of the **Great Turtle Island Abya Yala** [the Americas] the **Continental Commission Abya Yala** is mobilizing a team of **International Indigenous Human Rights Observers** to arrive at Standing Rock, North Dakota by **December 4, 2016**. The delegation is planning to arrive at the **Oceti Sakowin Camp** in advance of the December 5 deadline declared by District Commander John W. Henderson who announced on November 25 that the US Army Corps of Engineers (USACE) would be "closing the portion of the Corps-managed federal property north of the Cannonball River to all public use and access effective December 5, 2016."

A subsequent statement by the USACE on November 27 clarified that their role in the conflict over the **non-permitted drilling operation** of the Dakota Access Pipeline on the banks of the Missouri River is as a **manager of Federal property**, and that as such the USACE has "no plans for forcible removal" of the Oceti Sakowin camp north of the Cannonball River.

The mission of the International Indigenous Human Rights Observers will be to monitor, witness, and report on the developments at the site of the conflict between the Oceti Sakowin Dakota-Nakota-Lakota Nations and the **Civil Resistance Camp of Water Defenders** at Standing Rock who are facing the complicit and colluding forces of the corporation **Dakota Access Pipeline**, owned by **Energy Transfer Partners** and the aligned political and economic interests of the state of North Dakota who are driving the **Bakken Oilfields** pipeline project.

On November 28<sup>th</sup>, North Dakota governor Jack Dalrymple issued an order of “mandatory evacuation of all persons located in the proprietary jurisdiction of the United States Army Corps of Engineers” as referenced in the initial USACE announcement of November 25<sup>th</sup>.

In immediate response to the executive order by Gov. Dalrymple, **Standing Rock Sioux Tribe Chairman, Dave Archambault II** called on the Army Corps to reaffirm their position of no forcible removal and denounced the act by the head public office holder of the state of North Dakota stating:

“This state executive order is a menacing action meant to cause fear, and is a blatant attempt by the state and local officials to usurp and circumvent federal authority. The USACE has clearly stated that it does not intend to forcibly remove campers from federal property. The Governor cites harsh weather conditions and the threat to human life. As I have stated previously, the most dangerous thing we can do is force well-situated campers from their shelters and into the cold. If the true concern is for public safety than the Governor should clear the blockade and the county law enforcement should cease all use of flash grenades, high-pressure water cannons in freezing temperatures, dog kennels for temporary human jails, and any harmful weaponry against human beings. This is a clear stretch of state emergency management authority and a further attempt to abuse and humiliate the water protectors. The State has since clarified that they won’t be deploying law enforcement to forcibly remove campers, but we are wary that this executive order will enable further human rights violations.”



In light of these actions by officers and public officials of the local, state, federal and tribal governments, and in full recognition, acknowledgement, and in **Defense of the Universal Human Right of Self Determination** of the **Oceti Sakowin Dakota-Nakota-Lakota Nations** and all other **Original Nations of Indigenous Peoples** of the territories involved or impacted by the conflict over the Dakota Access Pipeline at **Standing Rock**, the Continental Commission Abya Yala presents the following clarifications:

The statements given this week by US government public officials, two by the USACE on November 25 and 27, and the order by Gov. Dalrymple on November 28 clearly establish that the purview of their claims to jurisdiction over the “public lands” is a derivative of the proprietary right purportedly ascribed to the US federal government.

In fact, and in law – this **proprietary interest** of the US Federal Government has **not** been established as a **valid legal right** under the principle of the **Rule of Law**, certainly not one that has been recognized as such by the Oceti Sakowin Dakota-Nakota-Lakota Nations, signatories of the **1851 and 1868 Fort Laramie Treaties**, and all other Original Nations of Indigenous Peoples of the territories involved.

Further to this point, as has been acknowledged by the US Federal Court itself in the case of the *Delaware Nation v. Pennsylvania (2004)*, the court ruled that the issues of the case were beyond the capacity of a US court to deliver justice, calling the case **nonjusticiable**, although it acknowledged that Indian title appeared to have been extinguished by fraud. This ruling held through the United States courts of appeals and subsequently the US Supreme Court refused to hear the case.

Not that a hearing before the US Supreme Court would provide any hope for justice on addressing the issue of any “**proprietary**” interest that the US Federal government may have at Standing Rock or anywhere else on the continent for that matter. **All US property law** is based on the **1823 Johnson v. M’Intosh** SCOTUS decision which established the colonial **Doctrine of Discovery of Christendom** as fundamental to all jurisdictions of all US courts, departments of government, and law enforcement officials from county cops to state militia, from state governors to the local dog catcher.

Most recently, this perverted principle of the “**Law of the Rulers**” (AKA European American settler state constructs of **Colonization** and **White Supremacy**) was reaffirmed by the US Supreme Court in the case of *City of Sherrill v. Oneida Indian Nation of New York (2005)*, where Judge Ginsberg invoked the perverted and dehumanizing reasoning the **Doctrine of Discovery** to affirm what amounts to a legaloid form of **apartheid** as articulated in the *1823 Johnson v. M’Intosh* decision, and extrapolated continentally the same year under the guise of the **Monroe Doctrine**.

Previously, and as example of the what may be expected of the US Justice Department’s role in defending the cause of justice regarding the issue of **easement rights** at the **drill site** of the **Dakota Access Pipeline** at **Lake Oahe** on the banks of the Missouri River, in 1954 the U.S. Justice Department submitted to the U.S. Supreme Court in the case *Tee-Hit-Ton Indians v.*

*United States* the argument that the Tee-Hit-Ton Indians should not receive monetary compensation for a taking of their timber because **“the Christian nations of Europe acquired jurisdiction over the lands of heathens and infidels.”**


In international context, in 2012 the **UN Permanent Forum on Indigenous Issues**, an advisory body to the United Nations Economic and Social Council, made the following recommendation to all member states, advisory bodies, and affiliated organizations of the UN system around the world:

“The Permanent Forum recalls the fourth preambular paragraph of the United Nations Declaration on the Rights of Indigenous Peoples, which affirms that all doctrines, policies and practices based on or advocating superiority of peoples or individuals on the basis of national origin or racial, religious, ethnic or cultural differences are **racist, scientifically false, legally invalid**, morally condemnable and socially **unjust**.”

Legal and political justification for the dispossession of indigenous peoples from their lands, their disenfranchisement and the abrogation of their rights such as the doctrine of discovery, the doctrine of domination, “conquest”, “discovery”, *terra nullius* or the *Regalian doctrine* were adopted by colonizers throughout the world.

While these **nefarious doctrines** were promoted as the authority for the acquisition of the lands and territories of indigenous peoples, there were broader assumptions implicit in the doctrines, which became the basis for the assertion of authority and control over the lives of indigenous peoples and their lands, territories and resources. Indigenous peoples were constructed as “savages”, “barbarians”, “backward” and “inferior and uncivilized” by the colonizers who used such constructs to subjugate, dominate and exploit indigenous peoples and their lands, territories and resources.

**The Permanent Forum calls upon States to repudiate such doctrines as the basis for denying Indigenous Peoples’ human rights.”**

In September of 2016, a Message of Solidarity with Standing Rock delivered on the ground at the

Oceti Sakowin Camp by the **Continental Commission Abya Yala** to the traditional and tribal leadership of the Dakota-Nakota-Lakota Nations, Signatories of the 1851 and 1868 Fort Laramie Treaties, and all other Original Nations of Indigenous Peoples of the territories involved. An extract of that statement:

**Continental Commission Abya Yala: Message of Solidarity to Standing Rock**

It deserves noting, that while Dr. Martinez called for the establishment of a distinct international body back in 1999 to address treaty disputes between Nations of Indigenous Peoples of Mother Earth and the Government States of the UN system, that was nine years before the UN itself adopted the Declaration on the Rights of Indigenous Peoples (2007) which now has unequivocally proclaimed Indigenous Peoples as "**Equal to all other peoples...**"

As Peoples, equal to all other peoples, our **treaties** are **also equal** to all **other treaties** and thus our traditional systems of **International Law**, from **Jurisgenesis to Jurisprudence**, from **Jurisdiction to Judgment**, must also be integrated without prejudice into the design, implementation, and evaluation systems of contemporary international law. This principle of **Equality as Peoples** which was not in place as official criteria for evaluation during the Treaty Study by Dr. Martinez, now mandates that the UN treaty study itself be updated and revised appropriately.

For example, in the case of the Dakota Access Pipeline, the public narrative has emphasized that because the project does not cross the Medicine Line (aka the US-Canada International Border), there is no **need for review** under relevant procedures by the US state department and the executive office of the president. This narrative is flawed, in that the **violations of International Law on the Traditional Territories of the Oceti Sakowin** as referenced in the 1868 Ft. Laramie Treaty which the Dakota Access pipeline is the latest example of criminal conspiracy and US government collusion are *prima facie* evidence for a **hearing before a competent international forum** as Dr. Martinez recommended in 1999. The borders of the Treaty Territories have been violated, once again.



**Conclusion:**

The overarching interests of all parties involved in the conflict at Standing Rock in material and spiritual dimension, in both symmetry and diversity in terms of the cultural constituencies and cosmetic world views engaged, all invoke the universal goal of **World Peace**. As was said by the Lakota Holy People, this world of peace begins within, it is an emanation of our shared human reality at the planetary level, not an expression of **any** deforming and dehumanizing racist doctrine. The goal of world peace lies as a seed in each human heart.

We are called to provide the necessary sustenance for that **individual seed** of world of peace to be nurtured, protected, and if necessary defended. This will be our legacy to the future generations. And as was very clearly stated by representatives of the Original Nations of Indigenous Peoples who participated in the **Global Indigenous Preparatory Conference** in Alta, Norway 2013 we cannot expect to have peace on earth if we are not at peace with **Mother Earth**.

To be at peace with Mother Earth requires that human society achieve equilibrium and **homeostasis** with the natural world. This culture of equilibrium also begins within each of our hearts and souls, in our homes and communities, and is communicated constantly by the ebb and flow of the **Sacred Spirit of Water, M’ni Wiconi – In Atzintli, In Nemiliztli**.



Therefore, we call upon **President Obama** and all jurisdictions of the US Government from

Federal, to State and Tribal Councils to reaffirm a shared commitment to these **Principles of World Peace**, to immediately and permanently **deny the easement** for the Oahe crossing and to **rescind** all DAPL permits. We call for President Obama act and intervene in order to walk back and rescind the two recent directives by the USACE and the order of evacuation by Gov. Dalrymple **by December 4, 2016** in order to allow our team of **International Indigenous Human Rights Observers** of the Continental Commission Abya Yala to visit our relatives of the Oceti Sakowin, review and assess the issues presented in this communique in a prayerful, respectful and purposeful manner, and accordingly follow through in the full and effective exercise of our fundamental **Human Rights** of **Self Determination** as **Original Nations** of **Mother Earth**.

## 2016-12-01 **UN rejects UK appeal on Assange**

On 30 November 2016, the United Nations rejected the United Kingdom's attempt to appeal the UN's February ruling in favour of Julian Assange.

The decision therefore stands and the UK and Sweden are once again required to immediately put an end to Mr. Assange's arbitrary detention and afford him monetary compensation.

Earlier this year the United Nations concluded the 16 month long case to which the UK was a party. The UK lost, appealed, and today - lost again. The UN instructed the UK and Sweden to take immediate steps to ensure Mr. Assange's liberty, protection, and enjoyment of fundamental human rights. No steps have been taken, jeopardising Mr. Assange's life, health and physical integrity, and undermining the UN system of human rights protection.

Now, the United Nations has found that the United Kingdom's request for review of this decision (filed on March 24) was inadmissible; the United Kingdom has now reached the end of the road in its attempt to overturn the ruling. As a member of the Security Council and the United Nations Human Rights Council, the United Kingdom must respect its commitment to the United Nations, and release Mr. Assange immediately. Now, more than ever, moral leadership is required; maintaining Mr. Assange's effective detention (which stands at six years as of 7 December, 2016) will only serve to green light future abuses against defenders of free speech and human rights.

Mr. Assange stated "Now that all appeals are exhausted I expect that the UK and Sweden will comply with their international obligations and set me free. It is an obvious and grotesque injustice to detain someone for six years who hasn't even been charged with an offence."

## **Assange: Frequently Asked Questions**

### **When did Assange enter the embassy?**

He entered the embassy on June 19, 2012 and applied for political asylum, which was formally granted two months later.

### **Why is Mr. Assange still in the embassy?**

The UK has encircled the embassy with police since he entered it and refuses to let him take up his asylum in Ecuador. The United States refuses to drop its attempts to pursue a national security case against Mr. Assange over WikiLeaks publications on Iraq and Afghanistan wars, Guantanamo bay and the US State Department. Sweden refuses to either drop its "preliminary investigation" or charge Mr. Assange with a crime. The UK states that it has spent more than \$10m on the encirclement so far (see <http://govcost.co.uk>) but [refuses to disclose](#) the breakdown of the cost.

### **What does the law say?**

International law says that a sovereign country has decided to recognise Mr. Assange as needing protection from political persecution on humanitarian grounds. Mr. Assange has a right to meaningfully exercise that protection through passage to Ecuador. Ecuador invoked a number of applicable conventions, including the 1951 UN Convention on Refugees. The United Kingdom and Sweden are also parties to the 1951 Convention and are obligated to recognise the asylum decision of Ecuador. While both states have been careful to avoid saying that they do not recognise the asylum, their actions can only be interpreted as a wilful violation of Mr. Assange's right to 'seek, receive and enjoy' his asylum. In international law, the obligation to protect persons from persecution under the 1951 Refugee Convention prevails over extradition agreements between states.

### **Why do the UK and Sweden disobey international law?**

The United Kingdom says it has a treaty obligation to extradite Mr. Assange to Sweden even though he has not been charged with an offense. There is a conflict between the United Kingdom's obligations to the 1951 UN refugee convention and its obligations under the European Arrest Warrant system. It is established law that these conflicts are to be resolved in favour of the higher obligation which is to the 1951 convention.

Rather than following international law, the United Kingdom has chosen to interpret the conflict in favor of its geopolitical alliances. The United Kingdom has a history of breaking international law in this manner, for example, in its invasion of Iraq, its cooperation with US rendition operations, and its facilitation of global mass spying via its intelligence service GCHQ. Sweden is also a party to these last two violations.

## **Why was he given asylum?**

Mr. Assange's asylum claim was upheld on two points.

Firstly, that there was a reasonable fear of persecution by the United States as a result of his publishing work, due to the ongoing US Department of Justice probe and political calls for his assassination. (See [here](#) and [here](#).)

Secondly, that neither the US, UK, Sweden, nor his home country, Australia, were willing or able to protect him. Diplomatic conditions are often applied to extraditions, so Ecuador asked the UK to veto an onwards US extradition; the UK refused. Ecuador asked Sweden to veto an onwards US extradition or come to the embassy to interview Mr. Assange; Sweden refused both requests. Ecuador granted Mr. Assange asylum thereafter, and now has obligations under international law to protect Mr. Assange. The asylum cannot be revoked.

## **What is the status of the US investigation against Mr. Assange?**

The US Department of Justice confirmed in its April 2014 court filings that the national security criminal investigation and "pending prosecution" proceed. The FBI is leading the investigation. A dozen other agencies have been involved. See [here](#).

## **What is the status of the Swedish investigation against Mr. Assange?**

Formally, it is at the stage of "preliminary investigation." Mr. Assange has not been charged. The investigation was previously canceled with the explanation that there were no grounds to accuse Mr. Assange. The prosecutor has yet to decide whether the investigation should turn into a formal investigation or not.

## **Is Mr. Assange accused of 'rape'?**

Over the past year, new information has emerged that both women explicitly deny having been raped by Mr. Assange. In a statement to the UK Supreme Court, the prosecutor acknowledged that the complainants wished only to ask the police for advice about HIV tests, having discovered they'd had both had sex with Mr. Assange. (There has never been an allegation Mr. Assange has HIV.) Neither of the women wished to lodge a formal complaint.

The woman of whom Mr. Assange is accused of the offence of "lesser rape" (a technical term in Swedish law) sent an SMS to a friend saying that she "did not want to accuse JA [of] anything" and "it was the police who made up the charges". The other woman tweeted in 2013 that she had never been raped. Both women's testimonies say that they consented to the sex. A senior prosecutor already dismissed the 'rape' accusation, saying that there were no grounds for accusing Mr. Assange on this basis. But a third prosecutor, lobbied by a politician who was running for attorney general, took over the investigation and resurrected the accusations against Mr. Assange. Due to the great number of incorrect reports of, it is best to rely on primary source documents in this matter, which are on the internet and the UK Supreme Court "Agreed Statements of Facts" agreed to by the UK, the Swedish authorities and Mr. Assange's legal team. ## **Are the two women CIA agents? Is the Swedish case a plot?**

While the Swedish government's close relationship with the United States may have a bearing on its public statements in the matter, Mr. Assange has never accused the two women of being influenced by these considerations. It has been widely misreported that he has. Telephone records show that one of the women says that she "did not want to accuse JA [of] anything", "it was the police who made up the charges". The Swedish authorities seized the opportunity to 'get' Mr. Assange. This was subsequently driven by a prominent Swedish politician, Claes Borgström, who became the centre of media attention as the state-funded representative of the two women. Sweden was just three weeks away from the general elections, and Borgström was running for the position of attorney general, and other scandals in his party had dominated the news. The case gained him extraordinary media exposure in the run up to the election by keeping the case alive, as well as replacing other stories. Borgström subsequently billed the state for 80 hours of speaking to the press in relation to just one of the women. At the time Borgström was also embroiled in the notorious Quick scandal, widely regarded as the worst in Sweden's judicial history. Since 2010, it has become increasingly apparent that personal and national prestige have played a role in maintaining the stalemate. (See [here](#).)

### **Why is the US investigation taking so long?**

The WikiLeaks investigation is classed as a national security case. Multi-year investigations are common in national security cases, but the US government has also intimated that it would wait until Mr. Assange was in Sweden before proceeding further. The investigation is politically and diplomatically charged as would be a future extradition. These factors are likely also weighing on US decision-making as to timing. See [here](#)

### **Is Mr. Assange Swedish?**

No. Mr. Assange is Australian and has no connection to Sweden and does not speak Swedish. He visited Sweden in August 2010 to give a lecture about the war in Afghanistan (where Swedish forces operate under US command).

### **What is the status of the United Kingdom's actions against Mr. Assange?**

Documents from Edward Snowden reveal that UK intelligence agency GCHQ was spying on WikiLeaks in 2012. The UK government admits to spending more than \$10m on the ongoing embassy police encirclement against Mr. Assange, a figure increasing about \$15k a day. Despite requests, it has refused to divulge further information. The encirclement expenditure has been a source of cross-party controversy in the United Kingdom, with the cost being equal 24,828 hospital beds or the training of 285 police. The UK government refuses to release most of its materials on Mr. Assange saying that to do so would compromise the United Kingdom's international relationships and national security. But several prominent figures have spoken out about the situation.

Angela Merkel was born in the D.D.R., the Communist portion of Germany in 1954. 





Gary Boyd Roberts, a genealogist at the New England Historic Genealogical Society thoroughly traced these connections in his book **Ancestors of American Presidents**. George W. Bush himself is directly related to 16 former U.S. presidents including George Washington, Millard Fillmore, Franklin Pierce, Abraham Lincoln, Ulysses Grant, Rutherford B. Hayes, James Garfield, Grover Cleveland, Teddy Roosevelt, William H. Taft, Calvin Coolidge, Herbert Hoover, Franklin D. Roosevelt, Richard Nixon, and Gerald Ford.







Bush is closely related to the king of Albania and has kinship with every member of the British royal family and the House of Windsor. He is related to 20 British Dukes, the 13th cousin of Britain's Queen Mother, and of her daughter Queen Elizabeth. He is 13th cousin once removed from Prince Charles and has direct descent from King Henry III, Charles II, and Edward I of England. Through the House of Windsor and King Henry III, the Bush's and Bill Clinton are genetically related as well.

*"According to Burke's Peerage, even according to the official genealogy, Bill Clinton is genetically related to the House of Windsor, the present royal family in Britain; to every Scottish monarch; to King Henry III of England; and to Robert I of France."* -David Icke, **Alice in Wonderland and the World Trade Center**



In 2004 George W. Bush ran as a "Republican" against "Democrat" John Forbes Kerry – his 16th cousin. These cousins, related to the same British and French monarchs, are also secret society brothers in the infamous Skull and Bones fraternity. John Kerry descends from King Henry II of England and Richard the Lionheart, leader of the third Christian crusade in 1189. He also has links to royalty in Albania, Sweden, Norway, Denmark, Russia, Persia, and France, but still not enough royal genes to top George Bush. Earlier in 2000 we see the same story - George W. Bush ran neck and neck with Al Gore; another supposed democrat and cousin of the Bush family.

*"Al Gore is a descendant of Edward I, Roman Emperors Louis I, II, and Charles II and is direct descendant of Charlemagne which makes him a distant cousin of Richard Nixon and George W. Bush. So the top "democratic" candidates against Bush in 2000 and 2004 were actually his cousins!"* -Michael Tsarion, **Where History Ends DVD**

*"Never in the history of the United States have two presidential candidates been as well endowed with royal alliances. There has always been a significant "royal factor," in those who aspired to the White House, with Presidents George Washington, Thomas Jefferson, Theodore Roosevelt, Franklin Roosevelt and Ronald Reagan, among others, all boasting blue blood links. Al Gore...a descendant of Edward I, he is also a cousin of former U.S. President Richard Nixon, who resigned from the White House in 1974 for his part in the Watergate scandal. However, Al Gore does have direct links to the Holy Roman Empire. He is descendant of Roman Emperors Louis II, Charles II, and Louis I and is therefore also a direct descendant of Charlemagne, the eighth-century Emperor. The problem is that Gore's Charlemagne links also make him a cousin of George W. By placing bloodline members on both sides of America's faux political dichotomy, the old monarchs have guaranteed their right to throne under the guise of democratic elections. Back in 1996 we see the same tactic as "Democrat" Bill Clinton defeated "Republican" Bob Dole, his cousin.



*"Even Bill Clinton and Bob Dole, who 'opposed' each other at the 1996 election, are distant cousins. They can trace their ancestry to England's King Henry III, who reigned from 1227 to 1273, and US Presidents William Henry and Benjamin Harrison ...Clinton has far more royal blood than Dole and is directly descended from the same bloodline as the House of Windsor, every Scottish monarch, and King Robert I of France. This is why he was the Brotherhood's choice."* -David Icke, **The Biggest Secret** (191-192)

The Windsor-Bush bloodline reaches from the American presidents, back to British/European royalty, and it doesn't stop there. It continues back through Roman emperors, all the way to Babylonian Kings and Egyptian Pharaohs near the beginning of recorded history.

From Marie Antoinette and King Louis XVI, the French line continues back through Louis XV-I, Charles XI-I, Henry IV-I, Philip V-I, Robert II and many other French monarchs. It passes the de Medici family, specifically Queen Catherine de Medici of France, who supported Columbus' expedition to the "New World" along with bloodline Queen Isabella of Castile, King Ferdinand of Spain, and the House of Lorraine. It was also Queen Isabella and King Ferdinand who started the 350 year Spanish Inquisition, which ordered the murder of millions who refused to convert to Christianity. And from the House of Lorraine, Duke Godfroi de Bouillon became the first Crusader King of Jerusalem.



*"Father George and wife Barbara [Bush] are both descendants of Godfroi de Bouillon who, in 1099, led European noblemen in the successful Crusade to recapture Jerusalem from the Islamic faith and moved into the King's palace at Temple Mount ... Godfroi de Bouillon was the first king of Jerusalem and the Duke of Lower Lorraine, a major region for the Illuminati bloodline ...So when George W. Bush, a descendant of the de Bouillon through his mother and father, talked of a "Crusade" against "Islamic" terrorism...this was no slip of the tongue...as was reported"* - David Icke, **Alice In Wonderland and the World Trade Center Disaster**



The British line goes back from Prince William and Harry, through Prince Charles and Princess Diana, to Queen Elizabeth II, King George VI and V, King Edward VII, Queen Victoria, King Edward III, II, I, and King George III, II, I. Then it passes through King James I who ordered and financed the now most-widely read version of the Bible. Before James came Mary Stuart, King Henry III, II, I, King John (signer of the Magna Carta) and back to the Plantagenet and Habsburg dynasties

under the Roman Empire. Other branches carried the bloodline to Scotland, Austria, Germany, Spain, Sweden and even Mexico:

*"This same bloodline also includes key Scottish families like the Lords of Galloway and the Comyns; Marie-Louise of Austria, who married Napoleon Bonaparte; Kaiser Wilhelm II, the king of Germany at the time of the First World War; and Maximilian, the Habsburg emperor of Mexico, who died in 1867. On and on it goes into country after country. This bloodline connects into every surviving royal family in Europe, including King Juan Carlos of Spain and the Dutch, Swedish, and Danish royal lines."* - David Icke, **The Windsor-Bush Bloodline**

Before the Habsburgs, the House of Lorraine and Charlemagne were the Merovingians (Meroveus/Merovee) who originally brought the bloodline to France and Northwest Europe. Back in 4th century Rome the bloodline passed through Emperor Constantine, the first professed Christian emperor who initiated the Roman Empire's transition into a Christian State and presided over the first Council of Nicaea. He was preceded by the Roman Piso family whom will be discussed at length later. Before them came Herod the Great of Biblical fame and Ptolemy XIV, son of the most well-known Roman emperor Julius Caesar. Caesar actually married into the bloodline through Cleopatra, the most well-known Egyptian Queen. A little further down this very same bloodline brings us to Alexander the Great:



*"One common link in this bloodline is Philip of Macedonia (382-336BC), who married Olympias, and their son was Alexander the Great (356-323BC), a tyrant who plundered that key region of Greece, Persia, Syria, Phoenicia, Egypt, Babylon, the former lands of Sumer, and across into India before dying in Babylon at the age of 33. During his rule of Egypt he founded the city of Alexandria, one the greatest centers for esoteric knowledge in the ancient world. Alexander was taught by the Greek philosopher, Aristotle, who in turn was taught by Plato and he by Socrates. The bloodline and the hidden advanced knowledge have always gone together."* -David Icke, **The Windsor-Bush Bloodline**

Back the bloodline goes past Alexander, past Nebuchadnezzar IV, III and other Kings of Babylon, all the way to ancient African Kings and Pharaohs of Egypt - Ramesis II, I, Tuthmosis IV, III, II, I, Amenhotep III, II, I and many more. For millennia these Kings, Queens, Pharaohs, and Emperors have obsessively interbred with themselves to preserve and spread their bloodline. They have ruled over us since the beginning of recorded history, claiming they were given divine right to the throne by God or gods.

*"This 'Divine right' is simply the right to rule by DNA. We have a head of state in Britain to this day who is only there because of her DNA and the whole freeloading hierarchy of the royal family is structured according to a person's DNA relationship to the king or queen ...what is royal rule by DNA if not outrageous racial and genetic elitism?
