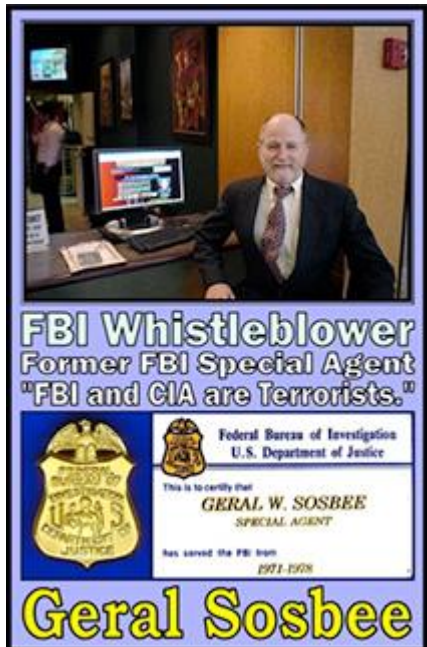

I document below crimes by the fbi which I have asked the VA to investigate. The evidence herein should provide further credibility for my past reports of torture and attempted murder of my person by the fbi.

Fbi continues to torture me every second, 24/7/365 by DEW and by heavy psychological assaults & provocations, often causing incapacitating results. Sleep deprivation, loss of hearing and cataracts are also exasperated by fbi high tech assaults on me.

My dear wife is also harassed and I think that her greater pain is in watching me wither away. However, I have never

felt more productive, accomplished and enriched in my life's work as I feel now.

Dear Director McDonald,

Thank you and the VA for all of the work performed in connection with my service related injuries.

I request that this letter be conveyed to the Office of the Inspector General for any action deemed appropriate. I set forth below evidence of crimes committed against my person, some of which are witnessed by highly trained and well respected experts at the VA Harlingen VCB, 2106 Treasure Hills Blvd., Harlingen, Texas 78550 and in the VA logistic center. These crimes include theft of government property, destruction of government property, interference with VA personnel, fraud and other offenses. I hope that some of the data herein will assist the VA and many veterans in addressing complex issues facing this nation, particularly injured veterans.

Background: I am a former FBI (fbi) agent and the subject of an extensive, decades long vendetta by the fbi to silence me from reporting their crimes. Many such crimes are summarized in my affidavits 2007 and 2014, my WRIT, my papers at ACADEMIA, my site SOSBEEVfbi.com, and thousands of posts on line.

Before I outline the evidence on fbi crimes, allow this brief statement on psychological operations by the fbi which tend to disorient or even destabilize the Target of fbi covert intelligence operations. By assaults on the veteran night and day, 24/7/365 for life, the Target of fbi crimes is observed

everywhere for his reactions to the torture (torture by DEW, street thugs, and toxic chemicals); then, any indications of confusion or neuroses are presented to a federal magistrate judge (a *de facto* fbi operative) for severe handling. See my report on "Committed To Healing". I believe that the fbi has thus forced many veterans into stress and beyond in such inhumane operations. Note that the fbi turns all police at every level against the fbi Target (see my reports on USPI Knipfing & Texas DPS Rodriguez; and see parts 19, a,b,c. at My Story In Detail).

Evidence of fbi crimes to which VA officers may be witnesses:

In February, 2016, I received hearing aids for service related injuries; the VA doctor who provided and fitted me with the aids is the excellent DR. PALACIOS, VA Clinic, Harlingen, Texas 78550 (Harlingen VCB).

Dr. Palacios explained and checked every item provided to me including the "Call Dex" accessory for my smart phone (Samsung). All was fine and I used the Call Dex. Shortly after I began using the hearing aid, the fbi accessed the frequency and began turning up the aids to high volume so that I could not easily use them. Then, about a year later the fbi entered my residence (as they have for 30 year) and purloined several parts and accessories to my hearing aid. One part that was stolen by the fbi was the Call Dex accessory for my phone; the fbi about two weeks later returned a different Call Dex that resembled the original Call Dex, but had a fixture or rectangular attachment that did not fit into my phone. I realized that the fbi simply wanted to play some kind of twisted game with the non-serviceable Call Dex which they planted in my residence. I tried to find another one and finally I asked the VA Denver Acquisition & Logistics Center in Denver to inspect the fbi planted device and replace it with one that works in my phone. The Inspector there, Kirk Beaty, advised me that the part that I sent him "...is an item that we do not distribute". He further advised me to contact the VA. His letter to me is dated May 22, 2017, reference Reply:001AL-A2-4, SSNS4711, VSD015.

On June 9, 2017 I met with the excellent VA officer COLLEEN HAINLINE and I provided her with the fbi planted Call Dex; she observed the Call Dex and appeared bewildered that the item was ever issued to me. She then contacted the Logistics Center mentioned above and she requested a Call Dex like the original one to fit into the oval connection on my phone. The item that I submitted to Logistics and to Colleen had a strange fitting that looked like a fitting for a laptop, but not for a phone.

I did not explain to anyone that I suspected the fbi of stealing my Call Dex and replacing it with the useless one that I provided to them. Please note that I do not generally explain my terrible experiences with the fbi because almost no one believes me, or they may think that paranoia sets in. In this regard see the fraudulent report by Doctor Holder (now a VA doctor at Harlingen VCB).

These three VA officers, HAINLINE, DR. PALACIO, INSPECTOR BEATY may be able to verify this report of theft or destruction of my VA issued CallDex. Please note that I am reluctant to enter the VA clinic in Harlingen, Texas, because I believe that Dr. Holder is dangerous; after he entered his fictitious finding of paranoia, he frightened my wife on a separate occasion by an out of context question :


“what do you think of GERAL’s fbi stories.?” Clearly Dr. Holder was fishing for something that might be useful against this vet. I believe that he is a potential threat to some veterans who may report retaliation by fbi/cia, etc.

Also, I have survived literally hundreds of assaults on my person, a few attempts on my life and extreme assaults by high tech, satellite based weaponry, street thugs/operatives for fbi, and extreme psychological operations designed to injure me in ways that most people cannot conceive. Some such assaults include chemical combinations to form kidney stone, injected biological infection near tooth #14, chemicals to disable organs, tracking device causing cerebral vascular disease, pumping toxic fumes into my residences for twenty years, *et al*.

I understand that no one is allowed to investigate the fbi, except the fbi (such a convenient protocol for corrupt police agencies). However, based on the evidence herein I hope that the VA might try to corroborate this report in order to preserve the integrity of VA health care by discouraging fbi subversion of law and contempt for veterans.
