**Glenn Greenwald** (born March 6, 1967) is an American lawyer, columnist, blogger, and author. Greenwald worked as a [constitutional](#) and [civil rights litigator](#) before becoming a contributor (columnist and [blogger](#)) to [Salon.com](#), where he focuses on political and legal topics.<sup>[1]</sup> He has also contributed to other newspapers and political news magazines, including [The New York Times](#),<sup>[2][3][4]</sup> [The Los Angeles Times](#),<sup>[5]</sup> [The Guardian](#),<sup>[6][7][8]</sup> [The American Conservative](#),<sup>[9]</sup> [The National Interest](#),<sup>[10]</sup> and [In These Times](#).<sup>[11][12]</sup>

Greenwald has written four books, three of which have been [New York Times](#) bestsellers: [How Would a Patriot Act?](#) (2006); [A Tragic Legacy](#) (2007), and [With Liberty and Justice for Some: How the Law Is Used to Destroy Equality and Protect the Powerful](#), released in October 2011. He also wrote [Great American Hypocrites](#) (2008).

In March 2009, he was selected, along with [Amy Goodman](#) of [Democracy Now!](#), as the recipient of the first annual Izzy Award by the Park Center for Independent Media, an award named after independent journalist [I.F. "Izzy" Stone](#) and devoted to rewarding excellence in independent journalism. The selection panel cited Greenwald's "pathbreaking journalistic courage and persistence in confronting conventional wisdom, official deception and controversial issues."<sup>[13]</sup>

In October 2010, he won the [Online Journalism Award](#) for Best Commentary, for his investigative article on the arrest of U.S. Army Private [Bradley Manning](#) as the alleged leaker to [WikiLeaks](#).<sup>[14]</sup> The same year, he was a Finalist for the [National Magazine Awards](#) category of "excellence in online reporting and commentary published as a blog."<sup>[15]</sup>

His commentaries "on surveillance issues and separation of powers" have been cited in [The New York Times](#), in [The Washington Post](#), in [United States Senate](#) floor debates, and in [House](#) "official ... reports on executive power abuses,"<sup>[16]</sup> and he appears on various radio and television programs as a guest political [pundit](#).<sup>[17]</sup>

His fourth book, entitled [With Liberty and Justice for Some: How the Law Is Used to Destroy Equality and Protect the Powerful](#). Metropolitan Books (Div. of Henry Holt and Company), 2011

### Remarks about his latest book and why he wrote it:

Major premise is that the US has completed the wholesale evisceration of the rule of law

- "rule of law": a term that is bandied about, rarely defined.
- **A broader paradox in the political discourse is the lack of definition of the words used most commonly and most often invoked:** biggest example is "terrorism" - basically, it has come to mean Muslims that commit violence against the US or otherwise oppose the agenda and interests of the US but it has no real fixed definition; also examples - "militant"; "civil liberties", "class warfare"; "due process" - basically empty slogans!
- "Rule of law" is not hard to define - it's clear and straight forward term: there is a consensus - we are all equally bound to a common set of rules regardless of power, position or prestige - no matter who you are - nobody is above the law, nobody is below it.
- Can look to lectures US and others have given to 3<sup>rd</sup> world countries who wanted to borrow money @IMF In 1980s, 1990s when people wanted to borrow money from IMF the US demanded they prove
  - 1998 - Thomas Carruthers article in Journal of Foreign Affairs - worked at World Bank; intended to be the gospel if they wanted to be deemed to be living under rule of law; had to prove

it - as follows:

- everyone in your society is bound under the law; no one is exempt
- hallmark of not living under rule of law is that your financial elites are able to use their superior economic power to gain exemptions from the rule of law, which produces a culture of lawlessness and we will not lend money to such a country
- We can also look to what the founders of the Republic said; disagreed about many things, but agreed that to have a just and legitimate society, the rule of law would be the central requirement, principal mandate going forward. They were huge fans of wealth inequality and income inequality. They thought that these inequalities were desirable and inevitable and that these could be legitimate if everyone was equal before the law.  
People object to the idea by saying you can talk all you want about how the founders believed in the supremacy of the rule of law, but they did not live by those rules. And, yes, it is self-evidently true that the founders espoused principles that they did not follow with their actions
  - **However:** the principle has become enshrined & inspirational - Americans were inculcated with this idea & these political values; it was an animating principle that has led to such things as civil liberties, women's rights, better treatment of native Americans, gays, and so on
- Greenwald wrote his book not because we have a principle of equality before the law that we violate but because **what has changed that we no longer affirm that principle of equality under the law:** people now renounce and reject the idea of the rule of law
  - In late 2005, started to write about politics full time and gave up law - at the time, N Y Times wrote that Bush gov't was spying on people on American soil without due process for the rights of individuals or getting warrants on American soil
  - He started to appear on radio & TV to talk about these things; thought it would be a straight forward scandal and when the US Pres gets caught red-handed doing illegal things, the illegal activity would stop and there would be something like impeachment, etc. But he did not get question about this, but rather "don't you want someone to be listening in when there are terrorists around" - questions baffled him.
  - Then later the Bush White House wanted the telecom companies who supplied the electronic data also be protected from any kind of legal reaction: supplant the rule of law, keep the companies immune from any punishment for breaking the law. There were celebrations for this amnesty being extended to private companies, as well as for gov't officials
- Thinks it started with Gerald Ford who spoke on behalf of forgiving Richard Nixon  
The only person who has really suffered was Thomas Town [?]; he was fired for exposing the Bush crimes of listening in on citizens
- Obama admin has brought more
- Two tier justice system - and for anyone accused of terrorism they can be arrested, detained and even killed for nothing - when Bush has the power to arrest American citizens on American soil without due process.
- It was the **epitome of radical** - first, to eavesdrop on own soil; second, to hold without warrant for a false reason, and now to target people for assassination without due process or any justification for example, the Maliwki family [Americans] killed by drones in Pakistan - no evidence of their guilt, no transparency, nothing -
- **nothing in terms of law**
- Extreme injustice results from a tiered level - law ceases to be the guarantor and

**Re:** Bradley Manning - Greenwald first wrote about the conditions of Manning

- Why did Obama administration do this? The motive was exactly the same when Bush took people to Gitmo - to send a signal: we the people who run the American gov't say we can do whatever we want to do and no one can do anything about it, and we can turn anyone into a Heinous criminal and you can't do anything about that either.
- He speaks of value of Occupy Movement - **SOURCE OF HOPE**

## Statement by the President on H.R. 1540

Today I have signed into law H.R. 1540, the "National Defense Authorization Act for Fiscal Year 2012." I have signed the Act chiefly because it authorizes funding for the defense of the United States and its interests abroad, crucial services for service members and their families, and vital national security programs that must be renewed. In hundreds of separate sections totaling over 500 pages, the Act also contains critical Administration initiatives to control the spiraling health care costs of the Department of Defense (DoD), to develop counterterrorism initiatives abroad, to build the security capacity of key partners, to modernize the force, and to boost the efficiency and effectiveness of military operations worldwide.

The fact that I support this bill as a whole does not mean I agree with everything in it. In particular, I have signed this bill despite having serious reservations with certain provisions that regulate the detention, interrogation, and prosecution of suspected terrorists. Over the last several years, my Administration has developed an effective, sustainable framework for the detention, interrogation and trial of suspected terrorists that allows us to maximize both our ability to collect intelligence and to incapacitate dangerous individuals in rapidly developing situations, and the results we have achieved are undeniable. Our success against al-Qa'ida and its affiliates and adherents has derived in significant measure from providing our counterterrorism professionals with the clarity and flexibility they need to adapt to changing circumstances and to utilize whichever authorities best protect the American people, and our accomplishments have respected the values that make our country an example for the world.

Against that record of success, some in Congress continue to insist upon restricting the options available to our counterterrorism professionals and interfering with the very operations that have kept us safe. My Administration has consistently opposed such measures. Ultimately, I decided to sign this bill not only because of the critically important services it provides for our forces and their families and the national security programs it authorizes, but also because the Congress revised provisions that otherwise would have jeopardized the safety, security, and liberty of the American people. Moving forward, my Administration will interpret and implement the provisions described below in a manner that best preserves the flexibility on which our safety depends and upholds the values on which this country was founded.

Section 1021 affirms the executive branch's authority to detain persons covered by the 2001 Authorization for Use of Military Force (AUMF) (Public Law 107-40; 50 U.S.C. 1541 note). This section breaks no new ground and is unnecessary. The authority it describes was included in the 2001 AUMF, as recognized by the Supreme Court and confirmed through lower court decisions since then. Two critical limitations in section 1021 confirm that it solely codifies established authorities. First, under section 1021(d), the bill does not "limit or expand the authority of the President or the scope of the Authorization for Use of Military Force." Second, under section 1021(e), the bill may not be construed to affect any "existing law or authorities relating to the detention of United States citizens, lawful resident aliens of the United States, or any other persons who are captured or arrested in the United States." My Administration strongly supported the inclusion of these limitations in order to

make clear beyond doubt that the legislation does nothing more than confirm authorities that the Federal courts have recognized as lawful under the 2001 AUMF. Moreover, I want to clarify that my Administration will not authorize the indefinite military detention without trial of American citizens. Indeed, I believe that doing so would break with our most important traditions and values as a Nation. My Administration will interpret section 1021 in a manner that ensures that any detention it authorizes complies with the Constitution, the laws of war, and all other applicable law.

Section 1022 seeks to require military custody for a narrow category of non-citizen detainees who are "captured in the course of hostilities authorized by the Authorization for Use of Military Force." This section is ill-conceived and will do nothing to improve the security of the United States. The executive branch already has the authority to detain in military custody those members of al-Qa'ida who are captured in the course of hostilities authorized by the AUMF, and as Commander in Chief I have directed the military to do so where appropriate. I reject any approach that would mandate military custody where law enforcement provides the best method of incapacitating a terrorist threat. While section 1022 is unnecessary and has the potential to create uncertainty, I have signed the bill because I believe that this section can be interpreted and applied in a manner that avoids undue harm to our current operations.

I have concluded that section 1022 provides the minimally acceptable amount of flexibility to protect national security. Specifically, I have signed this bill on the understanding that section 1022 provides the executive branch with broad authority to determine how best to implement it, and with the full and unencumbered ability to waive any military custody requirement, including the option of waiving appropriate categories of cases when doing so is in the national security interests of the United States. As my Administration has made clear, the only responsible way to combat the threat al-Qa'ida poses is to remain relentlessly practical, guided by the factual and legal complexities of each case and the relative strengths and weaknesses of each system. Otherwise, investigations could be compromised, our authorities to hold dangerous individuals could be jeopardized, and intelligence could be lost. I will not tolerate that result, and under no circumstances will my Administration accept or adhere to a rigid across-the-board requirement for military detention. I will therefore interpret and implement section 1022 in the manner that best preserves the same flexible approach that has served us so well for the past 3 years and that protects the ability of law enforcement professionals to obtain the evidence and cooperation they need to protect the Nation.

My Administration will design the implementation procedures authorized by section 1022(c) to provide the maximum measure of flexibility and clarity to our counterterrorism professionals permissible under law. And I will exercise all of my constitutional authorities as Chief Executive and Commander in Chief if those procedures fall short, including but not limited to seeking the revision or repeal of provisions should they prove to be unworkable.

Sections 1023-1025 needlessly interfere with the executive branch's processes for reviewing the status of detainees. Going forward, consistent with congressional intent as detailed in the Conference Report, my Administration will interpret section 1024 as granting the Secretary of Defense broad discretion to determine what detainee status determinations in Afghanistan are subject to the requirements of this section.

Sections 1026-1028 continue unwise funding restrictions that curtail options available to the executive branch. Section 1027 renews the bar against using appropriated funds for fiscal year 2012 to transfer Guantanamo detainees into the United States for any purpose. I continue to oppose this provision, which intrudes upon critical executive branch authority to determine when and where to prosecute Guantanamo detainees, based on the facts and the circumstances of each case and our national security interests. For decades, Republican and Democratic administrations have successfully prosecuted hundreds of terrorists in Federal court. Those prosecutions are a legitimate, effective, and powerful tool in our efforts to protect the Nation. Removing that tool from the executive branch does not serve our national security. Moreover, this intrusion would, under certain circumstances, violate constitutional separation of powers principles.

Section 1028 modifies but fundamentally maintains unwarranted restrictions on the executive branch's authority to transfer detainees to a foreign country. This hinders the executive's ability to carry out its military, national security, and foreign relations activities and like section 1027, would, under certain circumstances, violate constitutional separation of powers principles. The executive branch must have the flexibility to act swiftly in conducting negotiations with foreign countries regarding the circumstances of detainee transfers. In the event that the statutory restrictions in sections 1027 and 1028 operate in a manner that violates constitutional separation of powers principles, my Administration will interpret them to avoid the constitutional conflict.

Section 1029 requires that the Attorney General consult with the Director of National Intelligence and Secretary of Defense prior to filing criminal charges against or seeking an indictment of certain individuals. I sign this based on the understanding that apart from detainees held by the military outside of the United States under the 2001 Authorization for Use of Military Force, the provision applies only to those individuals who have been determined to be covered persons under section 1022 before the Justice Department files charges or seeks an indictment. Notwithstanding that limitation, this provision represents an intrusion into the functions and prerogatives of the Department of Justice and offends the longstanding legal tradition that decisions regarding criminal prosecutions should be vested with the Attorney General free from outside interference. Moreover, section 1029 could impede flexibility and hinder exigent operational judgments in a manner that damages our security. My Administration will interpret and implement section 1029 in a manner that preserves the operational flexibility of our counterterrorism and law enforcement professionals, limits delays in the investigative process, ensures that critical executive branch functions are not inhibited, and preserves the integrity and independence of the Department of Justice.

Other provisions in this bill above could interfere with my constitutional foreign affairs powers. Section 1244 requires the President to submit a report to the Congress 60 days prior to sharing any U.S. classified ballistic missile defense information with Russia. Section 1244 further specifies that this report include a detailed description of the classified information to be provided. While my Administration intends to keep the Congress fully informed of the status of U.S. efforts to cooperate with the Russian Federation on ballistic missile defense, my Administration will also interpret and implement section 1244 in a manner that does not interfere with the President's constitutional authority to conduct foreign affairs and avoids the undue disclosure of sensitive diplomatic communications. Other sections pose similar problems. Sections 1231, 1240, 1241, and 1242 could be read to require the disclosure of sensitive diplomatic communications and national security secrets; and sections 1235, 1242, and 1245 would interfere with my constitutional authority to conduct foreign relations by directing the Executive to take certain positions in negotiations or discussions with foreign governments. Like section 1244, should any application of these provisions conflict with my constitutional authorities, I will treat the provisions as non-binding.

My Administration has worked tirelessly to reform or remove the provisions described above in order to facilitate the enactment of this vital legislation, but certain provisions remain concerning. My Administration will aggressively seek to mitigate those concerns through the design of implementation procedures and other authorities available to me as Chief Executive and Commander in Chief, will oppose any attempt to extend or expand them in the future, and will seek the repeal of any provisions that undermine the policies and values that have guided my Administration throughout my time in office.

## **Iraqi Torture Scandal Touches Highest Levels of NATO**

A scandal unfolding in Denmark over the transfer of Iraqi prisoners by Danish forces to Iraq authorities, even as they knew they would be tortured, threatens to implicate the current Secretary General of NATO Anders Fogh Rasmussen, formerly prime minister of Denmark from 2001-2009.

The defense ministry in the government of former Prime Minister Rasmussen is charged with withholding its knowledge of Iraqi torture from legislators when a copy of a 2004 inspection at Al Makil prison in Basra was sent to Parliament.

According to an [article](#) last month in the Danish paper Politiken, portions of the report describing prisoner abuse were “blacked out,” with the reason given that such “information could harm Danish-Iraq cooperation.”

Yet, three months before the prison inspection, in May 2004, during a debate in the Danish Parliament concerning Iraqi prisoners, according to the paper [Politik & International](#) (English translation [here](#)), then-Prime Minister Rasmussen said the government would “disclose information about torture, if the government becomes aware that it occurs.” But evidently, this did not occur.

According to [The Copenhagen Report](#), a Danish English-language daily, the July 2004 investigation by Danish Army legal adviser Maj. Kurt Borgkvist revealed that “prisoners in Iraqi prisons had been burned with cigarettes, had their molars crushed and been beaten around their genitals. Some were even missing fingers, Borgkvist reported.” The resulting report included photographic evidence, which has been [described](#) as “Abu Ghraib-lignende” (“Abu Ghraib-like”) by the previous Danish defense minister.

[Rasmussen](#), leader of Denmark’s Liberal Party, resigned as prime minister in August 2009 in order to accept a position as NATO’s secretary general. Most recently, he was an outspoken supporter of NATO’s military support to the overthrow of the Gaddafi regime in Libya. Last November, the Liberal Party and its coalition partners lost power for the first time in almost a decade, losing to a coalition led by the Social Democrats. Rasmussen was also a key supporter of the US campaign to go to war in Iraq in 2003, ironically [citing](#) in a UN address Iraqi violations of international anti-torture treaties.

The scandal first arose in 2010 from documents released by WikiLeaks in the “[Iraq War Logs](#).” A November 2010 [article](#) at Ice News reported how a memo released by WikiLeaks described an inquiry by “a Danish Defence Ministry official” regarding “what happened at the American Abu Ghraib prison in Iraq after media

reports of torture and abuse in 2003.” Subsequently, “Danish soldiers continued to hand over prisoners to the facility, however, even after the torture was officially confirmed several months later.”

“That Denmark didn’t intervene in time simply shows that someone must have stopped the criticism at the political level”, said Social Democratic Defense Spokesman John Dyrby Paulsen. ‘That is also why we want an inquiry into all of this’, he added.”

An October 2010 story in *Politik & International* [noted](#) that “coalition forces share military reports” and “the Danish military has also had access to accounts on Iraqi police methods,” indicating that all the coalition forces, Denmark included, “had knowledge of the situation which was consistent with several highly critical warnings from organizations such as The International Red Cross and Human Rights Watch.”

A government commission into Denmark’s involvement in the Iraq war is expected later this year. The last Danish forces left Iraq last November.

The WikiLeaks logs also revealed that Danish forces in Iraq had been involved in turning greater numbers of prisoners over to the Iraqis than the Danish government had previously revealed.

According to a [report](#) at WikiLeaks Press, former Danish Defense Minister Søren Gade previously told the Danish Parliament that Danish troops had only 21 prisoners. But according to the leaked “War Logs,” “the actual number of prisoners taken in the period at a minimum of 95. Of these, 62 were handed over to Iraqi authorities, who were well known to be carrying out torture in Iraqi prisons.” In reply, the Defense Ministry “argued that the reason for the great disparity between the reported number of prisoners was due to the fact that many of the prisoners had been captured by British troops and that the Danish troops therefore could not be held accountable.”

But recent revelations have seen the number of prisoners actually handed over has grown from a later admitted 200 to a reported 500 or more. The higher number surfaced in a memorandum from Defense Chief Gen. Knud Bartels to the new Defense Minister Nick Hækkerup. (Bartels, himself, has recently assumed the position of [NATO’s Military Committee chairman](#).)

In a January 2 [article](#), The Copenhagen Post reported that Denmark’s former Defense Minister Søren Gade would be called as a witness in an upcoming trial, stemming from a lawsuit by six Iraqis who were arrested in winter 2004 by Danish forces supporting the US-led coalition forces in Iraq. The prisoners were turned over to Iraqi forces and subsequently tortured.

As the Post notes, “According to international law, soldiers may not deliver prisoners of war to another authority they suspect of mistreating or torturing prisoners.” This international prohibition is written into the UN Convention Against Torture, which states that no signatory to the treaty can return or *refoule* any person to a state authority “where there are substantial grounds for believing that he would be in danger of being subjected to torture.”

In a January 5 [editorial](#), the Post insisted that “ordering soldiers to turn a blind eye to the likely mistreatment of detainees amounts to a cold-blooded disregard for the well-being of others.” The paper called for the Danish military to cooperate with any investigations, “even if that means allowing top brass, former ministers or senior statesmen to be felled in the process.”

A further dimension to the scandal concerns not only the number of prisoners involved, but also the ways the Danes tried to hide their culpability.

The Bartels letter to Hækkerup also described, according to [Politiken](#), how “‘in a few cases’ Iraqi prisoners were illegally handed over to Iraqi authorities and that in many cases Danish troops avoided defence directives by letting British troops detain Iraqis during joint missions in order to avoid responsibility.”

The controversy over handing over prisoners to be tortured by Iraqi forces has not been limited to Denmark. Indeed, after the release of the WikiLeaks “Iraq War Logs,” numerous reports of such transfers of prisoners, despite knowledge of torture practices, were published in the [British](#) and [US](#) press.

According to the publication of one of the “Iraq War Logs” by the [Bureau of Investigative Journalism](#), in at least one case, a US military interrogator threatened a prisoner with being turned over to the notorious Iraqi Wolf Brigade, “where he would be subject to all the pain and agony that the wolf battalion is known to exact upon its detainees.”

Similar charges of coalition forces turning prisoners over for torture in Afghanistan have also raised [controversy](#). Last September, NATO announced it was suspending many such transfers after years of reports of torture by Afghan security and military personnel.

The Obama administration has pointedly refused to initiate any investigations into US torture, while the British government has announced formation of a government commission to look into the torture charges. The British commission, which has yet to begin its work, has been [boycotted](#) by human rights groups, who describe the commission as “toothless” and lacking “meaningful, independent” review.

NATO headquarters did not return a request for comment as of press time. In addition, attempts to verify details of “Iraq War Logs” information were stymied by what appears to be an Internet-wide suppression of the formerly available documents.

Epiphany, also called Three Kings Day, ends the Advent/Christmas season begun the 1st Sunday of Advent in December. The colors during Epiphany are white and gold. Traditional liturgical symbols of Epiphany are associated with the Magi. The symbols include crowns or pictures of the Wise Men, three gifts, a five pointed star, a globe portraying the world.

In our Institute we placed symbols +C+M+B+, symbolizing the Three Kings, over our doors invoking prayers and blessings to all who entered. This symbol placement occurs during Epiphany and it is especially done for homes. Around January 6, the symbol +C+B+M+ with two numbers before and two numbers after (for example, 20+C+B+M+12) can be seen written in chalk above the doorway of Christian homes. The letters are the initials of the Three Magi: Caspar, Melchior and Balthasar. They also abbreviate the Latin phrase *Christus mansionem benedicat*, "May Christ bless the house." The beginning and ending numbers are the year, 2012. The crosses represent Spirit Into matter, dispersed throughout the world. Marking the lintels of doorways is an ancient European practice with overtones of ancient magic (protection of the house). However, the symbols are now used throughout the world and usually represent a traditional Epiphany prayer and blessing.

### **The Blessing While Marking of Doorways**

“Peace be with this home (or place of work) and with all who live & enter here.”

### **Three Kings Cake**

It is usual on Epiphany to make a Three Kings Cake, hiding a small almond in the cake. Whoever finds the almond, representing the holy child, is specially blessed. ### **First Full Moon/Solar Fest of 2012**

Sunday (or Monday in the Midwest & East coast) is the Capricorn solar festival, 1st full moon of 2012. This solar festival full moon asks, “What is within the “womb” (Cancer) of humanity that is seeking externalization that will create the new world’s (Capricorn) Sharing Society, the new era, the new culture & civilization?”

The granddaughter of the Meiji Emperor, Princess Kaoru Nakamaru spent her early childhood in the Forbidden Castle in China. While at Columbia University and in graduate school, she furthered her research into international politics and since 1970, as a journalist, has interviewed kings and presidents, prime ministers and business people from many countries, and has given speeches, written books, and appeared on television as a commentator on international political affairs. In 1973, she was acclaimed in the U.S. magazine, Newsweek, as the "World's No.1 interviewer," and the Washington Post described her as "one of those rare women in the world with an outstanding international sensitivity."

Later, she was producer, director, and interviewer of her own Japan/U.S. talk show, for which she traveled to war-torn areas around the world and carried out positive discussions with the heads of state of those countries. Among those were Colonel Gadhafi of Libya and then-president of Iraq, Saddam Hussein—figures that were considered hostile by the West. Nakamaru even covered the frontlines during the Iran-Iraq War (1980-88) and video taken of it was shown to President Hussein who suggested that the war be immediately halted. The images of her broadcast on TV pressing President Hussein with the question "Why is this war being continued?" and asking Colonel Gadhafi, "Are you really a terrorist?" drew strong reactions. From those experiences, she exerted her energy into "personal diplomacy," serving as a go-between among warring countries, using her own funds.

In order to finance her "personal diplomacy," she bears all expenses. Kaoru's network of contacts include many "big names" of whom the staff at TV stations say "Even with our connections, there is no way we can approach these people," and this is linked to the fact that Kaoru, who is not affiliated with any organization, travels the world at her own expense and as a private citizen. Saddam Hussein, Moammar Gadhafi, top North Korean leaders, and other important figures that western journalists are unable to meet, talk with her—the main reason being "Princess Nakamaru is not a person who is moved by personal motives and so we considered a meeting with her."

In response to her personal diplomacy Kaoru established the "International Affairs Institute for World Peace" in New York in 1985, and in 1991, the "Following the Sun Association" was organized for people aspiring toward peace. In doing so, royalty and presidents from various countries as well as cultural figures signed their names to the statement, "I endorse all of your activities," and these people have been welcomed as advisers and special members. Accordingly, this began in earnest a movement of enlightenment in which the realization of a "one world" policy where the "path of life" is based on mutual understanding and trust, and not on a "one world" policy where the "path of power" is based on military power and tension. Since her days as an interviewer, she has so far traveled to as many as 186 countries.

Nakamaru's aim is for a "world peace through human renaissance. Wealth, fame, power do not make humans happy, as true happiness is borne from a heart filled with love, harmony, and peace. When

there is peace within the hearts of each person, from VIPs to average citizens, then world peace is realized. The phrase "one world" mistakenly conjures up a religious movement, but Nakamaru has absolutely no religion ties. Nakamaru believes in a religion of her own, but does not belong to any group, saying that "The world transcends all the many religions, races, ideologies so there cannot be just one.

As for her personal life, in 1966 she married Tadao Nakamaru, an actor who worked with Toshiro Mifune.

She has a son and a daughter.

In addition, she has maintained a close friendship with South Korea through its former prime minister, Kim Jong-Pil, and with North Korea through the late Kim Il Sung as well as Kim Yong Sun the Secretary of North Korea's Worker Party (who died in 2003 in a car accident), and has strived to improve relations between Japan and both Koreas as a bridge between the Japanese and Korean governments by bringing about the temporary return of a Japanese woman while at the same time acting as a mediator in bringing about a summit meeting between South and North Korea.
