**Colorado receives \$2.7 million** from IMLS for LSTA (Library Services and Technology Act). This is roughly 2/3 of the State Library's operational total. State funds make up the other 1/3.

Besides funding these ongoing state-focused projects, LSTA has been used to support the creation of many familiar statewide projects such as **AspenCat**, the **Marmot / Prospector catalog** link, CLEL's **StoryBlocks**, the **FindIt Colorado** mobile app, plus numerous local projects to improve **literacy, learning, collections, adult and teen services**, and more.

**Losing IMLS eliminates or severely reduces these services for libraries and the public:**

### Literacy programs for libraries and the public

- Check Out Colorado State Parks program
- Early literacy research (SPELL grant from IMLS)
- Grants and professional development for library staff
- Maker materials and training
- One Book 4 Colorado: 75,000 books given to 4-year olds statewide to encourage reading

- Summer reading programs: encourage children of all ages, teens, and adults to read and learn for fun and to prevent summer learning loss

## Colorado Talking Book Library

- Reduction of 9% of budget and loss of 7 staff will severely compromise daily service

## Digital Collection & Technology Services

- Colorado Historic Newspapers – 900,000+ pages of free online historic newspapers
- Colorado Virtual Library – access to resources for library staff and the public, including the Book Club
- SWIFT – interlibrary loan platform for more than 300 libraries
- Website creation and hosting, Plains to Peaks DPLA hub, and FindIt mobile app.

## Libraries in State Institutions

- Technical assistance to managers and library staff of 37 facilities at 3 state agencies
- Professional development for 49 library staff at 39 libraries
- Family literacy program for parents in state prisons to record a book that is sent to their child(ren)
- Loss of 15,000 books, magazines to support education, literacy, and re-entry

## **What is IMLS<sup>1</sup>**

The Grants to States program is the largest source of federal funding support for library services in the U.S. Using a population based formula, more than \$150 million is distributed among the State Library Administrative Agencies (SLAAs, or state libraries) every year.

For more than 60 years, the Library Services and Technology Act Grants to States program and its predecessor programs have supported the delivery of library services in the U.S. Although the legislation has undergone numerous reauthorizations, the basic function of the program, which merges federal priorities with state-defined needs, continues to this day.

Approximately ten percent of grant funds in recent years have supported library services for the blind and physically handicapped. The program also meets the

needs of the current and future library workforce. History of IMLS:

- 1956: Congress passed the Library Services Act (LSA), authorizing \$7.5 million annually for the extension and improvement of public library service in rural areas.
- 1962: LSA was reauthorized as the Library Services and Construction Act (LSCA), removing restrictions that limited funding to rural libraries and adding funds for library remodeling or construction.
- 1996: Congress shifted LSCA to the Library Services and Technology Act (LSTA) as part of the Museum and Library Services Act, replacing funding for library construction with a focus on new information technologies.
