
PARTICIPATION AGREEMENT
“Rainbow Family Tree Digital Storytelling Project”

("the Producer" including its licensees and assigns, including without limitation SHine SA)

1. You agree to take part in the Project as a storyteller as outlined below:
 - The Producer is gathering a group of 8-10 storytellers who will each create a 2-3 minute video drawn from their personal experiences using free editing software provided by the storyteller.
 - Ideally the stories will explore themes around homophobia; being an ally; interpretations of 'family' and gender stereotypes.
 - With assistance from facilitators, provided by the Producer, and other group members, the storytellers will participate in an on-line workshop to write and record a short narration (about 250 words); and select images (including personal photographs or drawings created by them), sound effects and music ("the Material") to complement the narration.
 - The storytellers will create a 2-3 minute video using the narration and the Materials ("the Video")
 2. Subject to clause 3 below, you assign to the Producer all your right title and interest in the Video, and you grant the Producer a non-exclusive licence in the Work, as defined below, for the Approved Purposes, as defined below.
 3. You consent to the Video and the narration and the Materials incorporated in the Video ("the Work") being used for any or all of the following purposes:
 - (a) to be licensed to SHine SA for inclusion on a DVD to be accompanied by a facilitator's guide and uses by SHine SA for training and education purposes;
 - (b) to be included in a screening during FEAST in November 2009 as part of a launch of the stories forming part of the Project;
 - (c) to be included in an on-line archive of the stories forming part of the Project
 - (d) to be referenced in PhD research being undertaken by the Producer on 'Digital Stories and Social Change' provided you may withdraw this consent by notice in writing to the Producer at any time prior to the commencement of the workshop.
 - (e) excerpts from the Work may be used by SHine SA and the Producer in promotion and publicity materials and activities, including on their respective websites and own promotional material
- ("the Approved Uses"). Any other use of the Video and Work may only be with your prior written consent.
4. You also consent to the Producer conducting follow up interviews with you for the PhD and for the results of such interviews to be used by the Producer in the PhD. **[delete if you do not wish to participate in these interviews]**. If you do consent, you may notify the Producer in writing if at any time after the interviews you do not wish them to be included in the PhD research provided that the Producer may continue to use the interviews provided your identity is concealed and you remain anonymous.

5. You give consent to the use by the Producer of your name, likeness, voice and biographical material about you solely in conjunction with the Approved Uses.
6. You acknowledge that the Producer is not obligated to use the Work in respect of any or all of the Approved Uses.
7. You agree that nothing in the Work shall to the best of your knowledge and belief contain anything which is defamatory.
8. You confirm that you have received permission from all of the individuals who appear in the photographs you are using in the Video and that you are using copyright-free images, sounds and music. If you do not have such consent from individuals in the photographs you should render them unrecognisable in the Video.
9. You undertake that the experiences described in the Work will be entirely honest and truthful and that you are not deceiving the Producer about the experiences or in any other way.
10. You agree that you shall not at any time either personally or by other means make any statement or disclose any information to any third party relating to the Project or the general affairs of the Producer or SHine SA.
11. You agree that the Producer has made it clear to you that any suggestions or advice given to you in the course of the Project are voluntary and it is ultimately your decision on whether you act on them.
12. You release the Producer from any claim by you or anyone on your behalf and arising out of the Project and/or your participation in the Project and you agree to indemnify fully and do indemnify the Producer in regard to any such claim.
13. The Producer will provide technical and creative support for you to create the Work.
14. This Agreement is governed by the laws of South Australia.
